Background:

Upton-by-Chester High School is located in Chester having circa 200 Staff and 1600 Pupils housed within approximately 10,000 m² of accommodation. Outline of the proposal and the service we delivered:

FCMS were employed to review Fire Provisions such as Fire Risk Assessment Strategy, Fire Policy, Emergency Planning arrangements and Fire Training requirements in order for the School and PFI to address the deficiencies identified in the order.
